Terms and Conditions of Radio Rental Agreement

Radio Electronic (Pty) Ltd ("Company") and the customer ("Lessee") hereby agree the following terms and conditions with respect to the rental services by the Company to the Lessee of the Radio, charger and other accessories as a set.

1. Definitions:

- 1.1 Equipment: Defines all rental equipment that includes the Radio, power cables, accessories, antenna, battery, charger as applicable.
- 1.2 Rental Period: The rental time, calculated in full days, from the date of collection to the date of return of the equipment. The rental period includes Saturdays, Sundays, Public holidays or days where Radio Electronic (Pty) Ltd is closed.
- 1.3 Company: Radio Electronic Close Corporation, Situated at 8 Sipres Street Windhoek or at 17 Fourteenth Road Walvis Bay.

2. Obligations of the Lessee:

- 2.1 Upon acceptance of the Equipment, the Lessee will check the external and working condition of the Equipment. In the event of any abnormalities, the Lessee shall inform the Company immediately.
- 2.2 **Failure to inform of such abnormalities within a day from acceptance of the Equipment shall be deemed to be a waiver of any claim therefore.**
- 2.3 In the event that the Equipment is stolen or lost, the Lessee shall immediately notify the Company of the fact so that the Company may suspend the services.
- 2.4 The Lessee agrees to keep the Equipment in the supplied case whenever not in use. The Lessee may not attempt to open, alter, repair or modify the Equipment without the prior written approval of the Company.
- 2.5 The Lessee shall return the Equipment to the Company in good working condition and in the same condition as was when the Lessee accepted the Equipment.
- 2.6 Rental costs will accrue until equipment is returned, and the Lessee will pay for any lost or damaged equipment. The Equipment is and shall remain the property of Radio Electronic (Pty) Ltd.
- 2.7 The Lessee will not use or operate the Equipment in any illegal manner or for any illegal purpose.
- 2.8 It is the Lessee's responsibility to immediately notify Radio Electronic (Pty) Ltd if any of the Equipment is lost, damaged or stolen.

3. Loss or Damage of the Equipment

- 3.1 In the event that the Lessee is unable to return the Equipment due to its theft or loss, or return the Equipment in a condition of such damage as is judged not to be repaired, the Lessee is liable for the Insurance excess amount of N\$ 1 000.00.
- 3.2 For any repairable damage, the Lessee agrees to pay the Company for the actual costs incurred by the Company.

4. Charges

Rental Charge – The Lessee shall pay the Rental Charge from the date of the Lessee's acceptance of the Equipment until the date of the Lessee's return of the Equipment.

5. Waiver

The Lessee hereby acknowledges that the Company is not responsible for the quality of the telecommunication services which may be provided using the Equipment. The Company is not liable for any discontinuance of, or interruption in the telecommunication, or any damages alleged to arise there from, which are not due to abnormalities of the Equipment. In no event shall the amount of damages the Lessee is entitled to exceed the total Rental Charges incurred by the Lessee.

6. Legal Recourse

If the Company and the Lessee have need for legal recourse to settle any dispute, the case shall be handled in accordance with the laws of Namibia and subject to the jurisdiction of Namibia without giving effect of the principle of conflict of laws.

7. Termination of Agreement

The Lessee acknowledges that he or she acquires no rights hereunder other than the use of the Equipment. In the event that the Lessee violates the terms and conditions of this Agreement, or the Lessee has furnished the Company with false information, the Company may immediately terminate this Agreement with the Lessee, whereupon the Equipment will be promptly returned to the Company and all charges in connection therewith shall be immediately due and payable. A credit return for early return of the Equipment by the Lessee is subject to the stated administration fee.

By applying my signature hereto I agree to have read the Rental Agreement Terms and Conditions and that the Lessee undertakes to abide thereby. The Lessee agrees to pay for service/rental charges and Value Added Tax (VAT) for Equipment rented and as agreed to in this executed Radio Electronic (Pty) Ltd Agreement. The Lessee also agrees to pay any shipping charges and repair charges on damaged Equipment. I understand if the Lessee does not return the Equipment in good condition at the end of this Agreement or fails to extend the rental period that the Lessee will be held responsible to settle any additional rental fees until the Equipment is returned, repaired or replaced.

I confirm that the information of the Lessee provided on the face of this Agreement is correct in all respects.
